TERMS & CONDITIONS FOR VENDORS

1. Introduction

These terms and conditions outline the rules and regulations for vendors operating on FUTUREBALL PARKS, LLC property. By accessing or using the property for vending purposes, you agree to comply with these terms.

2. Access to Property

- Vendors must obtain prior written permission from the property owner or designated representative before accessing the premises.
- Access is limited to the designated areas specified by FUTUREBALL PARKS.

3. Compliance with Laws

- Vendors must comply with all applicable local, state, and federal laws, including health and safety regulations, business licensing, and tax obligations.
- Vendors are responsible for obtaining any necessary permits or licenses required to conduct business on the property.

4. Insurance and Liability
